

# Since December 1, changes for drivers of passenger cars

On November 30 this year, the manual toll collection system on sections of A2 Konin-Stryków and A4 Wrocław-Sośnica motorways was terminated, and traffic on the sections since December 1 this year is taking place smoothly in the so-called „free flow”.

Drivers who enter a toll section of a motorway can already use new payment forms and do not have to stop to collect a cardboard ticket, and when exiting, to pay for the ticket at the collector's.

## ✓ New payment method for a drive

If you are a passenger car driver? For your drive on the above-mentioned motorway sections you can pay with:

- ✓ an [e-ticket](#), which you buy in the following forms:
  - **electronic:**
    - in the new [e-TOLL PL TICKET application](#) (free download in [Google Play](#) stores and in the [AppStore](#))
    - in the [applications of e-TOLL system partners](#)
  - **paper:**
    - at traditional service networks of our partners (you can check the current list of stations at [etoll.gov.pl](#))

For both forms, when purchasing, you must provide the minimum number of details (vehicle registration number, date, and time of commencement your motorway drive, and the place of entry and exit from the motorway).

You can buy a ticket 60 days in advance. **Its validity period is 48 hours** from the declared date and time of drive. You can return it the same way you bought it before the indicated drive start date.

- ✓ using the [e-TOLL PL application](#) or OBU / ELS on-board devices that transmit geolocation data to the e-TOLL system.

## ✓ Changes in traffic organization on A2 and A4

Due to the change in the toll collection system, since December 1 this year a new traffic organization is in force at the Toll Plazas (PPO) on A2 Konin-Stryków and A4 Wrocław-Sośnica motorways:

- at Stryków and Żdzary Toll Plazas, drivers use three rightmost entry and exit lanes. Middle lanes at the Plazas are excluded from traffic.
- at Żernica and Karwiany Toll Plazas, drivers use four rightmost entry and exit lanes. Middle lanes at these Plazas are excluded from traffic.

**Toll Plazas have been properly marked and have a speed limit of 50 km/h.**

## ✓ Payment verification for the use of A2 and A4 motorways

Customs and Tax Service Officers, the Police and inspectors of the Road Transport Inspection may verify toll payments for using motorways during roadside inspections. If it is found that there is no valid e-ticket or a GPS device transmitting geolocation data to the e-TOLL system (e-TOLL PL, OBU / ELS application) during such an inspection, the vehicle driver will be fined PLN 500. The penalty is also applicable for actions of a driver who covers, decorates, or otherwise prevents the proper reading of the vehicle's registration plates.

Inspection devices installed at motorway entry and exit points are also used to verify correct toll payments. For driving without paying the toll, an additional fee will be charged in the amount of PLN 500 with a payment period of 14 days. If it is paid within 7 days from the date of delivery of the summons, its amount will be reduced to PLN 400. The additional fee will not be imposed if a user purchases an e-ticket for the distance driven within 3 days from the end of the drive.

### Information for users of heavy vehicles using SENT

Since December 1, 2021, the e-TOLL PL application is the only application used to transfer geolocation data to the e-TOLL and SENT systems. Users using the SENT system in the forms available at <https://www.puesc.gov.pl/> may only use locators registered in the new ELS services or in the e-TOLL PL application. In SENT reports, please provide your locator number registered under new ELS services or from the e-TOLL PL mobile application.
